Thus, the Life Underwriters Association of Hong Kong (hereinafter "LUAHK") and Hong Kong Economic Times organize the Best Financial Planner Award (hereinafter "BFPA") to honor and recognize Hong Kong's most outstanding financial planners for their professionalism and dedication in serving the needs of their clients.
