- 申請者沒有連續 12 個月在任何一間保險公司以營業代理登記成為保險 代理人 / 保險經紀
- 報名費 \$200
- 必須為 2021 年度之保協會員
- 比賽期分上半年度(1月1日-6月30日)及下半年度(7月1日-12月31日), 比賽期內需達到以下業績\*要求:

銅獎:FYC HK\$42,000 或 FYP HK\$126,000,6 張批核的壽險保單銀獎:FYC HK\$84,000 或 FYP HK\$252,000,7 張批核的壽險保單

金獎: FYC HK\$168,000 或 FYP HK\$504,000,8 張批核的壽險保單

## Why insurance companies have to support New Star Award?

Newcomers face many challenges when entering into the insurance industry. LUAHK has launched "LUA New Star Award" and "LUA The Best Rising Star" to encourage these newcomers to commit in customeroriented services, and recognize them for excellence performance. Insurance companies should support this award that can boost up motivation and ethical training for newcomers and present a positive image to clients.

### **LUA New Star Award application criteria**

- Applicants MUST have less than 1 year working experience in the insurance industry (To apply New Star Award 2021 first half year, applicants MUST join the insurance industry on or after 1 Jan 2020; To apply New Star Award second half year, applicants MUST join the insurance industry on or after 1 July 2020)
- Applicants are registered as an insurance agent / insurance broker in an Authorized Insurer for no more than 12 months consecutively
- Application fee is HKD \$200
- Member of LUAHK in 2021
- New Star Award (First Half Year) Business accomplishment\*: Based on First Half Year production: 1 Jan to 30 June Bronze: FYC HK\$42,000 or FYP HK\$126,000 + 6 life cases Silver: FYC HK\$84,000 or FYP HK\$252,000 + 7 life cases Gold: FYC HK\$168.000 or FYP HK\$504.000 + 8 life cases

New Star Award (Second Half Year) Business accomplishment\*: Based on Second Half Year production: 1 July to 31 Dec Bronze: FYC HK\$42,000 or FYP HK\$126,000 + 6 life cases Silver: FYC HK\$84,000 or FYP HK\$252,000 + 7 life cases Gold: FYC HK\$168,000 or FYP HK\$504,000 + 8 life cases
